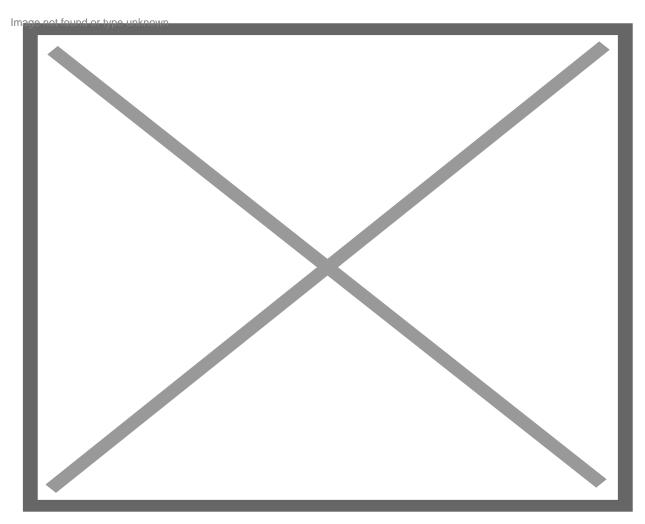
Viya Announces New CEO as Geraldine Pitt Retires After More Than Six Years at Firm
