

## St. Thomas East End Medical Center Corporation Has Announced Temporary Changes to Patient Intake and Visits

The St. Thomas East End Medical Center Corporation has instituted a series of new visitation policies in an effort to mitigate the spread of coronavirus (COVID-19).

According to a written statement Monday, "In an effort to ensure the safety of our patients, providers and staff during this time, we have instituted changes until further notice."

The changes include:

- All medical and dental patients will be pre-screened before being allowed to enter the center.
- STEEMC. will see medical and dental patients who are sick or require immediate medical attention
- STEEMCC will see patients with scheduled immunizations
- STEEMCC will see OB Patients with scheduled appointments

If you are sick and display any flu-like symptoms, please call the medical center before coming in. The STEEMCC representative will provide arrival instructions from our medical staff.

"If you have a scheduled medical or dental appointment and are not sick or display any symptoms, please stay at home. Your medical or dental provider will contact you on or around your appointment time to address any concerns you may have as well as provide prescription refills," the STEEMCC written statement said.
