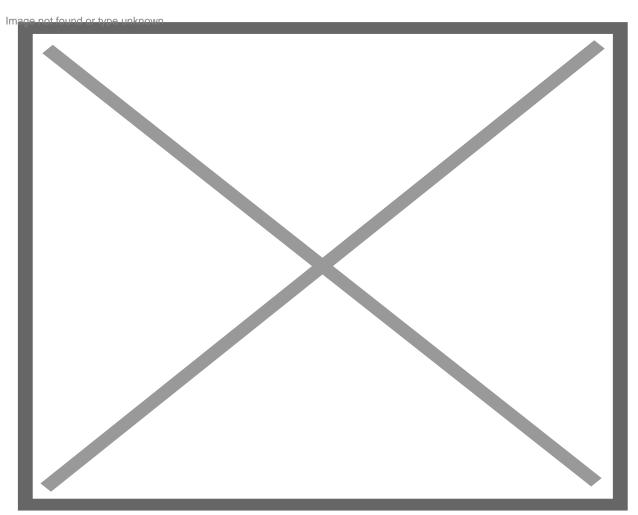
## V.I. Dept. of Labor Announces VI State Apprenticeship Council, a Regulatory Board Aimed at Fostering Apprenticeship in the USVI

The V.I. Department of Labor has announced the establishment of the VI State Apprenticeship Council(VISAC), a regulatory board comprised of 9 members appointed by the commissioner of Labor.

According to a D.O.L. release, VISAC membership includes two representatives from the Virgin Islands Department of Labor, one of whom must be the department's Legal counsel; two representatives from the Virgin Islands Board of Career and Technical Education; two representatives from the private sector who represent the interest of workers; two representatives from the private sector who represent the interests of employers; and one representative who is familiar with apprenticeable occupations.

What are the functions of the VISAC?

The VI Apprenticeship Council performs the following functions:

- Assists in the development of procedures and policies for the promotion of apprenticeship in the Virgin Islands.
- Provides advice and guidance to the Department of Labor in the establishment of standards of apprenticeship in trades and apprenticeable occupations suitable to the economy and conditions in the Islands.
- Approves apprenticeship standards that meet minimum basic standards of regulations.
- Assists in educating the community to apprenticeship.
- Ensures compliance of Affirmative Action Plans associated with apprenticeship standards.
- Acts as second level of appeal for complaints of apprentices.
