Thirty-Second Legislature of the Virgin Islands

May 8, 2017

An Act authorizing the reprogramming of a portion of the proceeds of the Matching Fund Revenue Bonds, Series 2009A (the “Series 2009 Bonds”), issued pursuant to Act No. 7081, as amended by Act No. 7095, and certain Interest Earnings allocated to the Virgin Islands Department of Education to the financing of certain critical deferred maintenance of Department of Education non-school support facilities and certain school facility capital projects which require priority funding at this time

PROPOSED BY: Senator Myron D. Jackson by Request of the Governor

1 *Be it enacted by the Legislature of the Virgin Islands:*

2 **WHEREAS**, the Department of Education has reviewed the needs of the Department of
3 Education facilities across the Territory and has determined that the \$724,163.66 of remaining
4 unused proceeds available under the Series 2009 Bonds, authorized pursuant to 2009 V.I. Act
5 No. 7081, as amended by 2009 V.I. Act No. 7095, and certain Interest Earnings allocated to the
6 Department of Education pursuant to V.I. Acts No. 6996 and 7004, are now required to be
7 reprogrammed to finance certain deferred maintenance of the Department’s non-school support

1 facilities and the renovation of an existing school building and establishment of new footings for
 2 a new building, which require immediate action; Now, Therefore,

3 *Be it enacted by the Legislature of the Virgin Islands:*

4 **SECTION 1.** The following capital projects authorized under the respective acts and in
 5 the remaining amounts described in this section are reprogrammed for the following projects and
 6 in the principal amounts described in this section:

9 **SECTION 2.** The aggregate amount of \$724,163.66 of the unused proceeds of the Series
 10 2009 Bonds authorized by Act No. 7081, as amended by Act No. 7095, and the interest Earnings

1 – DOE Funding authorized pursuant to Act No. 6996 and Act No. 7004, previously allocated to
2 the projects listed in section 1 of this act, are allocated to the following projects in the following
3 amounts:

4 1. Jane E. Tuitt (Phase I) – Renovation of an existing building and establishment of
5 new footings for a new building; \$643,000.00; and

6 2. Renovation of four bathrooms and an employee lounge at the STT VIDE HQ:
7 \$89,136.00.

8 **SECTION 3.** The funds allocated in section 2 remain available until expended for the
9 projects identified in section 2 of this act.

10 **SECTION 4.** All other provisions of Act No. 6996, Act No. 7004 and Act No. 7081, as
11 amended by 7095, remain in full force.

BILL SUMMARY

14 This is an Act to amend Act No. 7081, as amended by Act No. 7095 and Acts 6996 and
15 7004, with respect to the reprogramming of certain remaining proceeds from the Matching Fund
16 Revenue Bonds, Series 2009, and allocations to Department of Education from Interest Earnings,
17 for application to additional important capital projects for the benefit of the Department of
18 Education.
